LTI also hereby grants to above-named Licensee a non-exclusive, non-transferable license to use the GOD14 program recovery materials, the GOD14 Counselor and Client Workbooks, and the GOD14 name (hereby known as Licensed Product(s)) subject to the following terms and conditions contained herein. GOD14 is an acronym of Getting Off Drugs in 14 Weeks.
